Datelines:

The dateline for entry is the 15. October 2013. After this date a 10 % late fee will be added to each class entry. Until the 15. October the scratch of the horse will be accepted with no costs. After the 15. October up to the 26. October, scratches will be refund at 50%. The office fee is to pay in any case for this horse. The boxes must be paid in any case, but it is possible to change the horse by another.

The last dateline for entries is the 29. October 2013. After this day the entry lists will be official and there is no refund for scratched horses.
